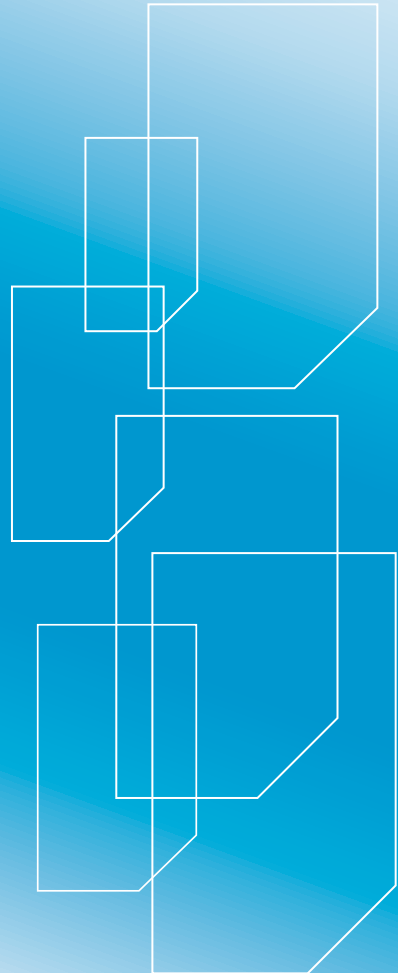

The USECU NextGen VISA Debit Card is free to all NextGen members between the ages of 14 and 26. Thereafter, the card is free to members with a total monthly Direct Deposit of \$500.00.

CREDIT AND DEBIT TRANSACTIONS

A "credit" transaction occurs when you select "credit", at a store for example. You will generally need to sign for a credit transaction. A "debit" transaction occurs when you enter a PIN (Personal Identification Number). Both types of transactions are withdrawn from your Checking account; however, your "credit" limit is higher than your "debit" limit. Although you are assigned two distinct limits, your Checking Account balance will dictate how much you can withdraw.
